This is to notify you that your request to update the iHealth COVID-19 Antigen Rapid Test to extend the shelf-life expiration date of the iHealth COVID-19 Antigen Rapid Test to 12 months, when stored at 2°C – 30°C, based on the results of your ongoing stability studies, is granted. Upon review, we concur that the data and information submitted in EUA210470/S010 support the requested update for the iHealth COVID-19 Antigen Rapid Test. The authorized labeling has been updated to include the 12-month shelf-life.
