#### SUPERINTENDENT'S REPORT

Dr. Carla L. D'Ambrosio, Superintendent of Schools:

#### Frank J. Carasiti Elementary School

- PARP is in full swing at the Frank J. Carasiti Elementary School. Goals are set high for all students to read each day to an adult. Mr. Crawford and Dr. Herbert will serve lunch to the students if FJC meets its PARP goal.
- In February the Suffolk County Sheriff's Officers Safety Program will visit kindergarten students to review practicing good safety habits and bully prevention. With parental permission, the program will include participation in

the New York State Operation Safe Child Program. This program coordinates with the Amber Alert system should a child become missing.

## RESOLUTION TO ACCEPT HEARING OFFICER'S REPORT AND RECOMMENDATION

**WHEREAS**, pursuant to Section 75 of the New York State Civil Service Law the Superintendent of Schools found probable cause to prefer Charges of misconduct against a certain employee; and

**WHEREAS**, by resolution on October 13, 2009, the Board of Education voted to serve the employee with the Charges and designated Howard M. Bergson, Esq., to serve as Hearing Office, to preside over a hearing in accordance with Section 75 of the New York State Civil Service Law, and to make findings of fact and recommendations to the Board of education; and

**WHEREAS**, in accordance with Section 75, on November 24, 2009, a hearing was held before the designated Hearing Officer whereat there was full and fair disclosure of the nature of the case against the employee and a full and fair opportunity for the employee to present a defense; and

**WHEREAS**, at the conclusion of the disciplinary hearing, the Hearing Officer rendered a written decision and report, dated December 22, 2009, setting forth findings of fact and making a recommendation as to the penalty to be imposed; and

**WHEREAS**, the Hearing Officer found the employee guilty of certain Charges and recommended that a penalty of dismissal should be imposed,

**NOW, THEREFORE, BE IT RESOLVED**: that the Board of Education hereby adopts the findings of fact and recommendation as to the penalty to be imposed made by Hearing Officer Bergson in his decision and report dated December 22, 2009 in their entirety and, in accordance therewith, the employee named therein is hereby terminated, effective immediately.

- Ms. Jenny Andersson invited the members of the Board of Education and all those in attendance at the meeting to attend the February 9<sup>th</sup> PTA meeting to be held at the Rocky Point High School in order to view the movie "Including Samuel," a film which examines the social and educational inclusion of youth with disabilities.
