**\*\*Program runs Monday through Friday, 9AM to 12noon at Holtsville Ecology Site located at 249 Buckley Rd, Holtsville. (except Thursday- July4th- closed)**

**\*\*NO TRANSPORTATION PROVIDED\*\***

**\*\*Activities include swimming, arts and crafts, organized games and exercise time. Program participants swim everyday. The pool is an extensive part of our program. Participants are not allowed in the deeper end of the pool. Certified lifeguards are always on duty. Locker rooms are available for changing but not locker space. Participants must carry their belongings. If your child is not interested in going in the pool, please reconsider registering for the program.**

**\*\*All participants MUST be completely toilet trained.**

**\*\*Physical disabilities need to be discussed on an individual case basis. Please call for more information. 631-451-6108**

**If you are accepted:**

**You will receive further information and an application that must be filled out. Your child is not accepted until the application is received, reviewed and accepted. You will receive written notification that your child has been accepted.**

**Please **DO NOT** send any money now. When you send in your full application, there will be an \$87.00 nonrefundable camp fee.**

**You will need to submit a copy of your child's IEP, updated vaccination record for all vaccinations given to date and the most recent physical exam to reflect clearance for your child to participate in activities of the program.**

**\*\*Learning disabled students are eligible for this program. This program will accept all students with an IEP, ranging from developmentally disabled or delayed, including Downs Syndrome and Autistic, to Learning Disabled. It is not a one-to-one ratio of counselor to child. We are not able to accommodate severely disabled children or those children that would require more than a one-to-five ratio of counselor to children. There are other programs that may be more appropriate for your child. Counselors are not all certified teachers. They may be Special Education Support Staff, college students interested in the field of Special Education or recreation, or High School students interested in working within our program.**
