PLEDGE OF ALLEGIANCE

Mrs. Sullivan welcomed those in attendance to the meeting and invited Dr. Ring to begin with the Superintendent's Report.

SUPERINTENDENT'S REPORT

In support of School Board Recognition Week, Dr. Ring presented the Board of Education members with plaques and thanked all for their efforts on behalf of the community.

Dr. Ring introduced Madison Jacobellis, Savannah McGinnis and Kayla Rooney (Girl Scout Troop 1133) to the podium as three (3) civic-minded students who are going above and beyond most students their age in their endeavor to obtain a Girl Scout Silver Award. The three (3) students staged a presentation educating the audience of the dangers of energy drinks currently on the market. They are also working with Legislator Anker's and Councilwoman Jane Bonner's offices to propose legislation banning the sale of energy drinks. Dr. Ring announced that an information sheet prepared by these three students on the risks associated with energy drinks will appear on the Virtual Backpack for each school.

Dr. Ring invited Mrs. Crossan to the podium to present the principal report for the high school.

Mrs. Susann Crossan, Principal, Rocky Point High School

- October was a busy month full of school spirit at the high school. The community was buzzing with Eagle pride on October 10th as we hosted Homecoming 2015. The annual parade kicked off the event with the theme, “Classic Video Games.” Mrs. Crossan thanked the grade level and club advisors who participated this day along with students and staff from other schools in the district as well. The first graduating class of Rocky Point High School, the class of ’75, were honored as the grand marshals of the parade and were celebrated on the field prior to the game. The participants shared that it was a nostalgic day that brought back many fond memories!
- Mrs. Crossan thanked the cheerleaders for their dedication to making homecoming a spirited and festive event. The school was completely decorated when the students arrived Friday morning. They also did a terrific job organizing the Powderpuff football game that took place Friday, October 16th due to rain. The cheerleaders also raised over \$4,000 during their “Pack the Track” event. This money will be donated to the Hewlett House and to local families going through a battle with cancer.
- On Saturday, October 17th the JV and Varsity Volleyball teams along with the Leaders Club hosted their annual “Dig Pink” event. The pink decorations and raffle prizes were a huge hit and over \$6,300 was raised for the Side-Out Foundation. Mrs. Crossan thanked the middle school for donating the money they raised from their pie eating contest towards this event.
- Our High School Marching Band performed at the Newsday Marching Band Festival on October 15th. They did an excellent job showcasing our musical talents as they performed a show titled “Light-em up Eagles.” It was a great evening of marching and music!
- Our Human Rights Club created a Public Service Announcement video on Human Trafficking. This video was shown in high school social studies classes as a way to create awareness and promote dialog on this important human rights issue.
- Our high school librarian, Jessica Schnall accessed a 3D Printer, on loan from BOCES, for our students to use in the library. Students from Mr. Schumacher’s technology classes had the opportunity to learn about how 3D printers are used, and we plan to bring the printer back again in the spring so our students can learn more about its different applications. The printer was used to create several items that took between several minutes to several hours to create. This new technology was engaging and fascinating to our students and staff.
- Our SADD club will host Red Ribbon Week from October 26th through the 30th. The club plans to create awareness of the dangers of drug and alcohol use by hosting a “no use” pledge competition among grade levels along with promoting students to share this message by wearing red during the week.
- On Wednesday, November 4th the high school and middle school will participate in an anti-bullying assembly program by All Access Productions. Ms. Crossan thanked the PTA for helping to fund this program.
- On November 4th, ten (10) students will participate in a leadership program called “Compassion without Borders” at Smithtown East High School. They will hear a message from a keynote speaker as well as participate in other breakout sessions with many students from across the Long Island.

- The “Be a Nicer Neighbor” Club will host Battle of the Classes on November 6th at 7:00 p.m. at the high school.
- Mr. Acritelli is organizing a Veteran’s Day assembly program for students in 10th and 12th grade that will take place during the school day on Monday, November 9th.
- NCAA Night will take place on Monday, November 9th in the high school auditorium at 7:00 p.m. for students who are interested in learning more about playing sports in college. Parents were encouraged to attend.
- The Pocket Theater performance, “Star Witness,” will take place on November 19th, 20th, and 21st.
- The Interact Club at the high school will be hosting their annual blood drive on Monday, November 23rd from 8:00 a.m. to 2:00 p.m. in the high school auditorium.
- The end of the first marking period is Friday, November 6th with report cards posted on the portal on Friday, November 13th. Please contact your child’s teacher if you have concerns about his or her progress.
- Ms. Crossan recognized an outstanding senior, Matthew Brewer, for his academic accomplishments. Matthew was named a Commended Student in the 2016 National Merit Scholarship Program. Approximately 34,000 students throughout the nation are being recognized with this honor based on their exceptional academic promise. This recognition denotes that Matthew is placed among the top 5 percent of more than 1.5 million students who entered the competition by taking the 2014 PSAT/National Merit Scholarship Qualifying Test. Ms. Crossan congratulated Matthew for this tremendous accomplishment and wished him continued success.

Dr. Scott O’Brien, Principal, Rocky Point Middle School

- The PTA will host the first Middle School Book fair of the year next week for all Middle School students. The PTA also hosted an assembly during lunch periods to

- introduce Middle School students to the Eagle card fundraiser. Dr. O'Brien gave special thanks to the PTA and all parent volunteers for their support of both events.
- The students and staff at the Rocky Point Middle School continued to support our local community. Students and staff have been collecting items of food and supplies as part of a Food Drive to support Veterans of Foreign Wars. Dr. O'Brien thanked our students and staff for supporting this project and helping those in need in our community.
 - The Middle School hosted its third annual Pep Rally and PBIS kick-off assembly on Friday, October 9th. The middle school staff has been very busy planning this very special event that highlighted Rocky Point PRIDE as we introduced our school wide PBIS program known as Positive Behavior Intervention Support. This event showcases our school PRIDE and approach to recognizing and rewarding student positive behaviors. Dr. O'Brien gave special thanks to all teachers and staff who helped to make this event possible.
 - The Middle School staff also participated in a pie-eating contest to conclude the Homecoming events on Friday, October 9th. Students and staff voted for the staff member they believed would win the contest and all money raised was donated to support cancer research through the "Dig-Pink" fundraiser. Dr. O'Brien thanked all staff who participated and helped with this event and congratulated the winner of the pie-eating contest, Mr. Darren Goldstein.
 - The Broadcom MASTERS (Math, Applied Science, Technology and Engineering for Rising Stars) is a national science competition for 6th, 7th and 8th grade students. Each affiliated science fair in the United States has the honor of selecting the top 10% of 6th, 7th, and 8th grade participants as Broadcom MASTERS nominees and inviting these top students to apply to the national competition online. This nomination is considered an honor, and distinguishes these projects as among the best in the nation.

From the pool of more than 2,200 entrants in 2015, the top 300 semifinalists were named, and only 30 finalists were invited to compete during the national finals week in Silicon Valley, California a few weeks ago. This competition honors creativity, innovation, and comprehension of all fields of STEM. Dr. O'Brien conveyed his hearty congratulations to Bryant Liu for being selected as a Broadcom MASTERS national finalist this year and representing RPMS and Rocky Point School District.

As a Broadcom MASTERS finalist, Bryant Liu presented research to judges and the public at the Computer History Museum, competed in hands-on science and engineering team challenges and even visited NASA Ames, Tesla, Google and Lucasfilm. They experienced the week of a lifetime: making 29 new friends with whom to explore the nation's capital, meeting top scientists and engineers, and being inspired to use their skills in STEM to make a difference in the world. All finalists received \$500, along with other prizes—including a Raspberry Pi microcomputer, WICED sensor device, and even a minor planet named in his/her honor.

Thanks to Bryant Liu's success, Broadcom Foundation is awarding RPMS \$1,000 to use for the benefit of STEM education at RPMS. Mrs. Katsapis, Bryant's teacher, will receive a one year subscription to *Science News* magazine, and a minor

planet will also be named in their honor for supporting independent research at the middle school level.

Broadcom Foundation and Society for Science & the Public thanked RPMS for providing opportunities for students to pursue their own creative ideas and project based learning. Dr. O'Brien stated he is proud to provide opportunities for students to pursue their own creative ideas and project based learning and proud of Bryant Liu's accomplishment. He hopes to see more students enter the regional science fair and apply to the Broadcom MASTERS in 2015!

- Last school year, the RPMS was approached to participate in a new initiative entitled Invitational Education. Members of our school community were invited to participate in a survey to provide feedback to the principles of creating, sustaining, and enhancing positive learning environments that support students and staff reaching their full potential.

An Invitational Education team was created to support the notion that schools can move "beyond the tests" to insure that students, staff, and parents have a more positive and successful school year. Through this process, the Rocky Point Middle School has been named a nominee for the 2016 International School of Invitation Award with the results of this process being increased academic success, attendance, effort, collaboration, positive behaviors, and morale.

The RPMS was selected as a host school to over 60 international administrators, teachers, and students on October 20th. Educators from Hong Kong, China, Mexico and Italy visited the RPMS as a model of Invitational Education. Dr. O'Brien conveyed the schools excitement and pride to share our positive climate initiatives with our visiting educators from around the world.

- The annual Book Character Dress-Up Day will take place on October 30th. Students may come to school dressed as their favorite book or historical character.
- Mrs. Towlen reminded the audience that JAE will be having its Veteran's Day celebration on November 6th in the old gym.

- On October 30th, FJC will be hosting our annual Storybook/Harvest Parade. Children can choose to dress up as farmers, scarecrows or other harvest themed inspirations. - Parent, Erica Bergmann expressed her concern for security at the middle school morning drop-off. Dr. Ring indicated it would be investigated and he would be in contact.
- Student, Jennifer Carlson was concerned that the Identity Gender Policy has been tabled. Gender neutral bathrooms/locker rooms may be the answer. Mrs. Sullivan indicated she is sympathetic to the issue and is still looking into it.
- Parent, Dr. Chris Pinkenburg asked for explanation of LAP and Dr. Ring provided same. Dr. Pinkenburg suggested that the district should look for an alternative for their GO MATH program. He also asked if milk was taken out of a specific classroom in the JAE school. Dr. Ring indicated that it had due to allergy concerns.

Mrs. Sullivan indicated she would like to look into the situation. Dr. Pinkenburg submitted an article entitled, "Overreaction" for Dr. Ring's and the Board's review.

Parent, Albert-Paul Garske, discussed his displeasure over the tabled Student Gender Identity policy and the practices being utilized in the schools to date.

Parent, Nicole O’Neil, expressed her concern for the well-being of the transgender students. Believes Rocky Point should follow the state guidelines.

Parent, Kathleen Heggers, expressed her concern how Algebra II – Concepts and Applications is being conducted as a course in the High School. Based on information she had gathered, she believes it should only be a lab and not graded. Dr. Ring said he is looking into the matter, and adjustments will be made if necessary.

Employee, Denice Shaughnessy, thanked Security and Buildings and Grounds employees for their efforts before the international visit. Mrs. Shaughnessy shared her concerns for the well-being of the groundskeepers that were pulling weeds before the event because of the physically demanding nature of the tasks. She stated her belief that an alternative method should be looked into. Mrs. Sullivan indicated she would look into the matter.
